Town Board meeting called to order 7:00 p.m.

Agenda Approval: Motion (Denise Wiedemeier/Mark Monnette) to approve the agenda as changed to next board meeting to follow the annual meeting. Motion carried with 4 yes votes.

Minute Approval: Motion (Mark Monnette/Dan Van Beek) to approve the minutes of February 17, 2015 board meeting as presented. Motion carried with 4 yes votes.

Treasurers Report: Motion (Mark Monnette/Denise Wiedemeier) to approve the treasure's report as presented. Motion carried with 4 yes votes.

Payment of Vouchers: Motion (Mark Monnette/Denise Wiedemeier) to pay vouchers as presented: Electronic Pay #15042 thru 15060 for \$11,851.91 and Local Pay #18713 thru #18753 with #18730 and 18740 thru 18743 and 18745 thru 18753 void for \$22,548.40 for a total payout of \$34,400.31. Motion carried with 4 yes votes.

Public Input: Lud Richter, County Y, Town of Peshtigo, questioned the information and records being made available by the County Land Information department.

Resolution #032015-1 County Assessment: Motion (Mark Monnette/Denise Wiedemeier) to approve resolution #032015-1 opposing county wide assessment of property as proposed by State of Wisconsin. Motion carried with 4 yes votes.

Discussion on Recycling Center operations took place with Dan Van Beek working to get prices for Electrical work needed.

Quotes on replacement tractor for the town were received. Quotes were opened and will be studied by board members.

Dog Park on Town Property: Motion (Mark Monnette/Denise Wiedemeier) to allow a Peshtigo group to develop a dog park at the former Heath Lane Landfill site. After discussion on who would cover costs and other items needed (this would be covered by the Peshtigo dog park group. Motion carried with 4 yes votes.

Appointments to Town Commissions: Motion (Herman Pottratz/Mark Monnette) to approve reappointment of Mike Biehl and Eugene Frank to three year terms (April 1, 2015 – March 31, 2018) on the Town Plan Commission. Motion carried with 4 yes votes.

Motion (Mark Monnette/Dan Van Beek) to reappoint Lou Ann Seils and appoint Russell Bauer to three year terms (May 1, 2015 – April 30, 2018) on the Fire Commission. Motion carried with 4 yes votes.

Motion (Dan Van Beek/Denise Wiedemeier) to reappoint John Peterson – Alternate to three year term (February 1, 2015 – January 31, 2018) to the Board of Appeals. Motion carried with 4 yes votes.

Discussion about e-mail received from Town Attorney Dave Spangenberg which he received from County Corporation Counsel Gale Mattison regarding hazardous spill at a home on Highway 64. After board discussion Herman Pottratz stated he would reply to County Corporation Counsel Gale Mattison by letter that he would take care of.
