Town Board meeting called to order at 7:00 p.m.

Agenda Approval: Motion (Denise Wiedemeier/Dan Van Beek) to approve the agenda as published. Motion carried with 5 yes votes.

Minute Approval: Motion (Mark Monnette/Dan Staudenmaier) to approve the minutes of June 21 and 30, 2016 board meetings with corrections as to who was in attendance at the June 30, 2016 meeting. Motion carried with 5 yes votes.

Treasurers Report: Motion (Mark Monnette/Denise Wiedemeier) to approve the treasure's report as presented. Motion carried with 5 yes votes.

Payment of Vouchers: Motion (Denise Wiedemeier/Dan Staudenmaier) to approve payment of vouchers #16194 thru #16219 for \$15,898.22 and #19225 thru #19252 for \$21,915.11 for a total \$37,813.53 with voucher #19226 and #19228 are void. Motion carried with 5 yes votes.

Announcements: Shore Drive Bridge will be closed for rebuild. Detour is Heath Lane and Leaf Road to Krause Rd.

Thank You from the bike group for the towns hospitality in letting them use the Town Hall as a stopping point. The Town received a letter from Representative John Nygren regarding the pickup of deer on town roads.

Pulverize Keller Road: Motion (Denise Wiedemeier/Dan Van Beek) to go ahead with the pulverizing old blacktop on Keller Road for an additional cost of from \$12,000.00 to \$15,000.00 more for project. Motion carried with 5 yes votes.

Special Assessment for Mercury Spill: Motion (Denise Wiedemeier/Dan Staudenmaier) to obtain legal advice from Town Attorney on whether we can place on assessment roll spread over a number of years instead of one time. Motion carried with 5 yes votes.

Gates on Pond Road: Motion (Dan Staudenmaier/Denise Wiedemeier) to place one gate just East of the Bird Viewing Stand and the other at the end of the road. Motion carried with 4 yes votes and one no vote by Mark Monnette.

Summer Jobs: Motion (Dan Staudenmaier/Herman Pottratz) to advertise for quotes for gravel and grading of Town Roads. Mark Monnette will develop the specifications for the project. Advertise in paper with an opening date of August 11, 2016 at 12:00 noon and award the quote to lowest contractor. Motion carried with 5 yes.

Shoreland Zoning Hearing: Motion (Mark Monnette/Dan Van Beek) to hold a public hearing at the Town of Peshtigo Town Hall regarding the proposed County Shoreland Zoning for Marinette County. Hearing will be on August 4, 2016 at 6:30 p.m. Place ad in newspaper for the meeting and that a majority of the Town Board may be present and no action will be taken. Motion carried with 5 yes votes.

Department head and committee reports were given. Denise Wiedemeier stated the Town of Amberg wants to work with us on E-Cycle program. She will get the details and report back to the board.
